Showing keen business proficiency at a very young age, he began studying at the Marist school, since his parents worked, and helping them on Thursdays and Sundays at the sausage factory.

After completing his studies and a year working in his family's sausage factory business (Fábrica de Embutidos DÍAZ), he created the company ALIMENTACIÓN DÍAZ MESONERO, S.A. and opened his first supermarket on Calle Iscar Peyra in 1974, a franchise of 22 supermarkets and 314 employees in Salamanca and Zamora. He also created a company in Portugal with a hyper-market and warehouse in Aveiro, distributing products for the market in Salamanca; company transferred in 1995.

In the foodstuffs sector, he was vice chairman of VIVO, S.A. During 15 years, he negotiated national-level mergers of SPAR-CENTRA and VIVO, the subsequent merger of VIVO and MAESA, as vice chairman of VIMA, S.A, all national shopping centres.

In 1986, he entered the construction sector by participating in companies in Salamanca and León, and directly in the construction of homes in Salamanca, Zamora, Béjar and Madrid.

He is among the founding partners of TELEVISIÓN SALAMANCA, today integrated in RETECAL and TELEVISIÓN CASTILLA Y LEÓN.

In 1988, he created the company DISAN ALIMENTACIÓN, S.A., dedicated to the large-scale catering and restaurant business, operating various cafeterias, including some in universities, public schools, hospitals and residencies.

In 1989, he created the company Grupo Ferpal, S.A., which carries out various activities (Construction, Real State development and Real State consulting).

In 1993, he created the company ASOCARSA, S.A., of which he is vice chairman, which runs the Public Slaughterhouse under concession of the Salamanca city council. He has also developed the remodelling and extension project for HOSPEDERIA PEÑA DE FRANCIA, with a three-star hotel spanning 2,000 m2 and a new panoramic building covering 2,400 m2 with restaurant.

He was elected member of the Salamanca Chamber of Commerce and Industry in 1979, a position that he has held without fail during twenty years, vice chairman during one mandate and chairman between 1991 and 1998.

Between 1993 and 1998, he was the Chairman of the Regional Council of the Chambers of Commerce of Castilla y León at its headquarters in Valladolid.

In 1999, he received the Medal of Merit from the Salamanca Chamber of Commerce and Industry.

He currently runs various business activities directly: real state and hostelry.
